Flexible Spending Accounts Program

Open Enrollment: March 1 - April 30, 2025

Why join Island Flex?

The Island Flex flexible spending accounts (FSA) plan is a great way to stretch your benefit dollars! It allows you to use before-tax dollars to reimburse yourself for eligible out-of-pocket medical and dependent care expenses, which decreases your taxable income and increases your spendable income.

If I am currently enrolled, do I need to re-enroll?

Yes, you must submit a new enrollment form during the open enrollment period to designate the amount you would like to contribute for the new plan year. Otherwise, your participation in the plan year will end on June 30, 2025.

If I still have funds left in my Medical Spending Account and do not wish to add any new money to my account, do I need to re-enroll?

No, you do not need to re-enroll in the Plan if you only wish to use the funds remaining in your medical spending account, up to the maximum \$550 limit, that will be automatically rolled over to the new plan year. However, if you would like to make contributions during the 2025-2026 plan year, you must submit a new enrollment form during the open enrollment period indicating how much you would like to contribute for the new plan year. If you only have rollover funds and not contributing, the monthly administration fee will be deducted from the rollover balance instead of your paycheck.

Webinar Sessions

There will be webinar sessions during the open enrollment period for those who are unable to attend one of the scheduled workshops. These 45-minute virtual meetings will allow participants to listen to the presenter, view the slide presentation to learn more about the Plan, and ask questions. To access the webinar, the participant must log on to the website and follow the prompts. All that is needed is a computer with internet access and audio capabilities.

Note: State employees are allowed to use up to 1-1/2 hours of work time (this includes travel time) to attend an Island Flex workshop, or 1 hour to view a webinar.

Sessions are approximately 45 minutes to 1 hour long.

If you are currently participating in Island Flex, your enrollment will end on June 30, 2025.

To continue, you must re-enroll during open enrollment.

Use-It or Rollover \$550

The FSA ruling by the U.S. Treasury allows you to rollover up to \$550 of unused amounts remaining in your medical FSA plan to the following plan year.



This reduces the risk of losing your FSA healthcare contributions at the end of the plan year and eliminates the mad scramble to spend remaining FSA funds.

Sign up for the Island Flex Debit Card

Cash-flow friendly - FSAs are directly debited for eligible medical expenses, eliminating "out-of-pocket" cash payments and the wait for reimbursement.
